School of Audiology & Speech Language Pathology

Audiology and Speech Language Pathology is an upcoming field in health sciences. There is a dearth of Speech Language Pathologists and Audiologists in India as very few colleges provide educational facilities in this field.

Bharati Vidyapeeth (Deemed to be University) decided to fulfil this long-standing deficiency in Maharashtra by starting a School of Audiology and Speech Language Pathology (SASLP) in the educational capital, the city of Pune under the Faculty of Health Sciences in August, 2006. SASLP is located at the Dhankawadi Campus of Bharati Vidyapeeth (Deemed to be University).



About Audiology & Speech Language Pathology

Audiology is a branch of science that deals with hearing and balance related disorders. Students of Audiology are educated regarding the anatomy and physiology of the normal and abnormal auditory system. They are trained in identification, assessment and differential diagnosis of auditory disorders. These include disorders of the middle ear, inner ear, auditory nerve and the central auditory nervous system. With training, students develop expertise in audiological rehabilitation, which includes recommendation of hearing devices including hearing aids and cochlear implants and rehabilitation. They also learn about assessment and management of tinnitus, vestibular disorders and auditory processing disorders.

Speech-Language Pathology deals with the normal and abnormal aspects of voice, speech, language, cognition and swallowing. Students of Speech-Language Pathology are trained in diagnosis, differential diagnosis and management of speech and language disorders, which includes voice disorders, speech sound disorders, fluency disorders like stuttering and cluttering, communicative problems associated with hearing impairment, intellectual disability, cerebral palsy, cleft palate, autism spectrum disorders, oral and laryngeal cancers, stroke/paralysis, and learning disorders, among others.

Rehabilitation Council of India (RCI) has officially recognized BV (DU) School of Audiology and Speech Language Pathology as a **Center of Excellence!** Owing to the remarkable achievements of Bharati Vidyapeeth (Deemed to be University), which holds a NAAC A++ (CGPA 3.60) accreditation and a NIRF ranking of 59 (2025).

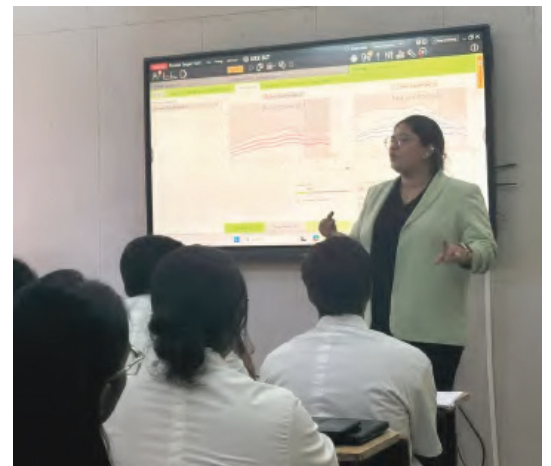

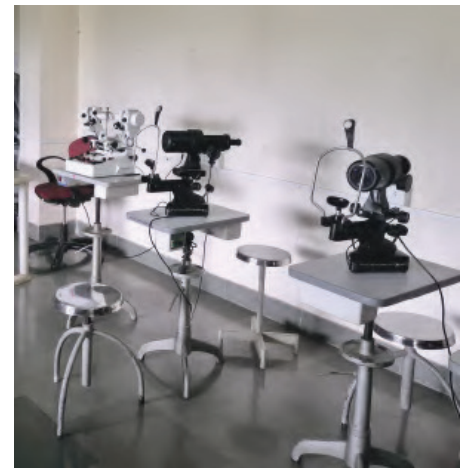

Academic Programs

The college conducts an undergraduate program, Bachelors in Audiology & Speech Language Pathology (B.ASLP), a four year course; two postgraduate programs - Masters of Science (Audiology) and Masters of Science (Speech Language Pathology) and two doctoral programs- Ph.D. (Audiology) and Ph.D. (Speech Language Pathology).

The highlights of the academic program are as follows:

The programs are affiliated to Bharati Vidyapeeth (Deemed to be University) and are recognized by the Rehabilitation Council of India (RCI).

Infrastructure at the college includes classrooms and seminar halls with facility for audiovisual presentation through smart boards.

The teaching program is conducted by qualified and experienced faculty with an equal focus on theory, practicals, clinics and research.

Guest lectures by experts in the field are arranged regularly to broaden the horizons and promote exchange of information.

The college has a well-stocked library with books and scientific journals. New books and journals are added regularly.

The staff of the college carry out orientation programs for allied professionals, which include surgeons, general practitioners, pediatricians, neurologists, physiotherapist, special educators, psychologist, teachers of the normal schools and special schools for children with communication disorders, etc.

Workshops/Seminars/Symposia are conducted to orient the students on recent advances in the field and to update the knowledge of the professionals in the field.

Academic activities of the college include clinical case conferences and journal clubs to orient the students to the basics of research.

Students present scientific papers at conferences under the guidance of the faculty.

Faculty are invited at national & international conferences/symposiums to conduct hands on training workshops & deliver lectures.

Clinical Services

SASLP has state-of-the-art facilities for the evaluation and rehabilitation of individuals with speech, language, cognitive, balance and hearing disorders. Besides the college, these services are offered at the Department of ENT and the Department of Pediatrics of the Bharati Hospital and Research Centre. Assessments are regularly carried out in wards, Neonatal Intensive Care Unit, Pediatric Intensive Care Unit, and High Risk OPD, Voice clinic. Management is carried out in wards of Bharati Hospital and Research Centre for individuals with speech & language disorders, oral and pharyngeal cancers, voice problems, swallowing disorders and vestibular disorders. Camps are conducted at old age homes, schools for children with communication disorders and in rural areas. School screening programs are conducted to identify children with speech, language, literacy and hearing problems.





Audiology

Universal newborn hearing screening, school screening for hearing & Central Auditory Processing Disorders (CAPD) as well as bedside audio-vestibular screening

Assessment and differential diagnosis of auditory disorders, which includes facilities such as pure-tone audiometry, speech audiometry, glycerol test, immittance evaluation, recording of Auditory Evoked Potentials (ABR/ BERA, MLR, LLR, MMN, P300), Auditory Steady State Response (ASSR) and Oto-acoustic Emissions (OAE).

A Speciality clinic for cochlear implants

Bharati Hospital and Research Centre & School of Audiology and Speech Language Pathology have been empaneled for free Cochlear Implant surgeries and post Cochlear Implant Rehabilitation under the ADIP (Assistance to Disabled Persons for purchasing/ fitting of hearing aids) scheme of Ministry of Social Justice and Empowerment. In addition self funded, and NGO funded cochlear implant surgeries and post implant rehabilitation is regularly conducted. CSR funding for implant maintenance and use is present.

Speech Language Pathology

Assessment of individuals with developmental language disorders like hearing impairment, intellectual disability, cerebral palsy, autism spectrum disorders, specific language impairment and learning disabilities using tests like 3DLAT, REELS 4, LPT, CLQT, DDST-II, CELF, Picture test of receptive language, ALD, MMALA and other indigenous tests developed at SASLP. Assessment of adult neurogenic speech and language, cognitive communicative disorders like aphasia, dysarthria, apraxia, RHD using tests like Boston Diagnostic Aphasia Evaluation (BDAE), Apraxia profiling and others.

Perceptual and instrumental assessment of individuals with voice disorders using Computerized Speech Lab (CSL), Stroboscopy, Dr. Speech software, MDVP, Spirometer and others. Perceptual and instrumental assessment of individuals with resonance disorders using Nasal view and Nasometer.

Assessment of individuals with fluency disorders using tests like Stuttering Severity Index (DII), Kiddy CAT & others. Assessment of early literacy using tests like ERS, PAM, C-TOPAH, DALI etc. Assessment of individuals with articulation disorders using tests like Photo Articulation Test (PAT), Diagnostic evaluation of articulation and phonology (DEAP) and others.

Assessment of individuals with swallowing disorders using tools like Dysphagia Evaluation Protocol, Manipal Manual for Swallowing Assessment, FEES, Vital stim etc.

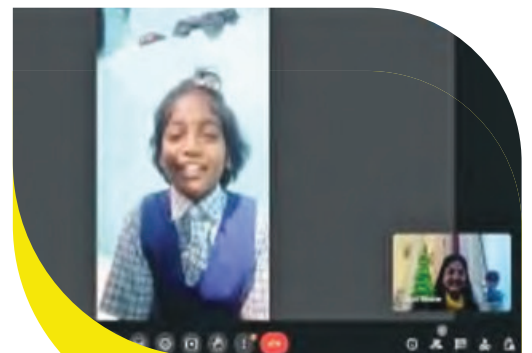

Extension Activities

Outreach services are provided in and around Pune to cater to the needs of individuals who cannot avail services at the college premises. Services are provided at special schools, old age homes and at the extension centers in places like Satara, Wai, Panchgani, Khandala, & Ratnagiri. 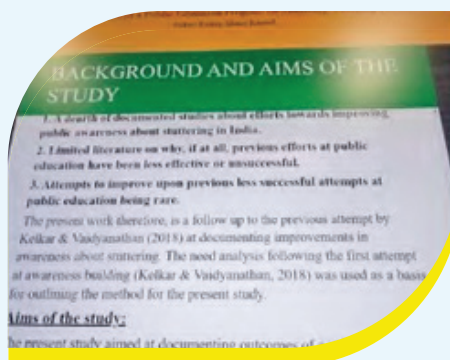

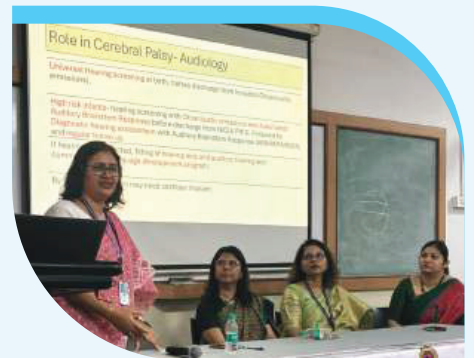

Ten percent (10%) supernumerary seats over and above the sanctioned intake are reserved for NRI/ Foreign quota, candidates from Andaman & Nicobar, Lakshadweep, Northeast and Jammu & Kashmir. Nature of entrance test

For B.ASLP Program

AB-2026 is an entrance test for admission to Bachelor of Audiology & Speech Language Pathology.

The Entrance Test will consist of one question paper, set in English and will contain 200 Multiple choice objective type questions, each with four alternatives. There will be 60 MCQs on Physics, 60 on Chemistry, 80 on Biology (Botany & Zoology) or 80 on Mathematics. They will be set on the topics in the syllabus of 11&12 std. One mark will be allotted for correct or most appropriate answer. There is no negative marking for entrance test.

Candidate will have to choose Biology or Mathematics for the entrance test. The entrance test will consist of questions on Physics, Chemistry, and either Biology or Mathematics. The choice may be provided during filling up of online application form. Choice of the section once made will not be changed

All candidates desirous of taking admission for First Year Masters of Science (Audiology) / Masters of Science (Speech Language Pathology) post graduate programme must appear for " BV-MSc. AUDIOLOGY-26/BV-MSc. SPEECH LANGUAGE PATHOLOGY-26" respectively"

The Entrance Tests "BV-MSc. AUDIOLOGY-26/BV-MSc. SPEECH LANGUAGE PATHOLOGY-26" for admission to First Year Masters of Science (Audiology) / Masters of Science (Speech Language Pathology) program will consist of a total of 50 marks and will be for 60 minutes duration.

The "BV-MSc. AUDIOLOGY-26/BV-MSc. 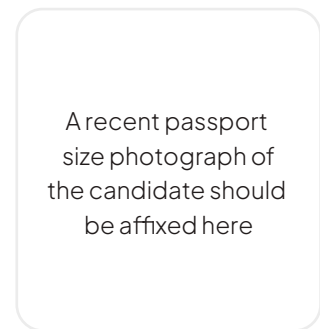
