Guidelines & SOPs

Dr. Patangrao Kadam Scholarship

In the memory of the beloved Founder Chancellor, Hon'ble Dr. Patangraoji Kadam, Bharati Vidyapeeth and Bharati Vidyapeeth (Deemed to be University), Pune has instituted **Dr. Patangrao Kadam Scholarship for scholars and ranked students**, and **Dr. Patangrao Kadam Freeship** for the needy and deserving students from economically weaker section of the society to enable them to access quality education. This scheme also provides better education facilities for children who are capable but cannot afford to continue with their higher education.

A) Dr. Patangrao Kadam Scholarship for meritorious students

i) For Non-Health Sciences Institutions:

Aspects of Scholarship Scheme:

- Scholarship at entry level/ 1st year admission restricted to undergraduate courses only
- Scholarship continuation for subsequent 2nd, 3rd, 4th year of studies
- Scholarship for meritorious students in sports, arts and cultural activities

Minimum eligibility requirements:

- Shall have passed XII or its equivalent examination
- Shall have appeared for BVDU CET or State CET examination for non-health science courses

Scholarship Scheme:

- Scholarship at entry level / 1st year admission to undergraduate courses only:**

- All student who obtained / secured 90% and above of marks in XII or its equivalent examination	25% in Tuition fees or Rs. 25,000/- whichever is minimum
- All student who obtained / secured 80% and above of marks in XII or its equivalent examination	10% in Tuition fees or Rs. 10,000/- whichever is minimum

b) Scholarship continuation for subsequent 2nd, 3rd, 4th year of studies

- All the students who have received scholarship for the 1st year shall be eligible to continue the same benefit / same amount of scholarship for each year.
- The scholarship is for entire programme. However, for the subsequent years, if the student fulfills the following criteria.
 - ✓ If student clears all the subjects in first attempt and secures 1st class scoring 65% or more in each year.
 - ✓ 75% attendance in the classroom is mandatory.

Terms & Conditions:

- The candidate who paid the prescribed fee and confirmed the admission shall be eligible to apply for the scholarship.
- The candidate has to apply within 3 months from the date of admission.
- Necessary documents need be submitted alongwith application
- Application should duly recommended / forwarded by the Head of the Institute/College.
- Candidates qualified for the scholarship are required to submit affidavit mentioning that all the documents provided are valid.
- Undertaking shall be taken from the applicants that they are not getting scholarship from any other sources.
- Names of selected candidates for the scholarship may put on website alongwith his/her photograph.
- Scholarship amount will be disbursed in form of cheque in the name of candidate.

B) Dr. Patangrao Kadam Freeship for needy and deserving students from economically weaker section

Dr. Patangrao Kadam Freeship - financial help to the poor and deserving students from financially weaker section of the society.

Criteria for financial help:

- Freeship for children of teaching, non-teaching staff and alumni
- Freeship on death of the only earning member in family
- Freeship for handicapped students / siblings who may be differently abled

Minimum eligibility requirements:

- Age Group: 17-20 years to apply for non-health sciences UG courses
- Annual income: Family annual income shall be below Rs. 3.00 lakhs

Freeship for:

a) Freeship for children of teaching, non-teaching staff and alumni:

Terms & Conditions:

- The candidate has to apply for fee waiver in the prescribed format within the given stipulated time.
- The applicant will have to provide proof of family income and to justify the eligibility for the financial help.
- Only eligible candidates will receive a fee waiver of 100% in tuition fee as a financial help.
- Due date to apply will be 31st August, every year.
- Eligible candidates to submit the affidavit mentioning that all the documents provided are valid.
- The candidate has to wait for the selection letter. Till that time, he/she has to pay the prescribed fees and confirm the admission.
- If the candidates fail in any exam or discontinue the study during the process, the scholarship will also be cancelled and the paid amount will be reimbursed.
