

Former Chief Justice of India Hon'ble Mr. Justice Ranjan Gogoi Visits Bharati Vidyapeeth (Deemed to be University) Institute of Management and Research, New Delhi

New Delhi, July 18, 2025 — The Law Placement Cell of Bharati Vidyapeeth Institute of Management and Research (BVIMR), New Delhi, hosted a momentous event today, welcoming Hon'ble Mr. Justice Ranjan Gogoi, Former Chief Justice of India, to deliver a Distinguished Address to the students of the Law Department.
