

- **Candidates must be present in- person**
- The Candidate should bring **print out of self verification done on State CET Cell website** (Provisional allotment letter) with college admission receipt and Bonafide certificate, in case the candidate has already taken admission in another College.

- The candidate should bring all the original documents for admission process. If a candidate is unable to produce original certificate at time of his/her admission on account of admission already secured in other institute, he/she shall produce original Bonafide certificate and Photo copies of all such documents attested by institute. Such candidates shall be required to pay the fees immediately at the time of admission and such candidates shall be permitted to submit the required original document **on or before 19/9/2025** otherwise his/her admission will stand automatically cancelled and fees paid shall be forfeited as per CAP admission policy.
- The candidate has to pay prescribed fees of **Rs. 16000/-** immediately at the time of admission.
- Candidate has to cancel his/her earlier admission at his/her own risk and cost. Candidate should cancel previous admission immediately to confirm the allotted admission in this Institute.
