The **admission process** of Bharati Vidyapeeth (Deemed to be University) Institute of Management & Research Admissions Process is divided into **four phases** which are mentioned below:



1. **Online Registration:** Registration Starts in February month every year and ends in June. Aspirants need to apply online through the mentioned below link and need to register for various BVDU Common Entrance Tests (CET).

All the eligible candidates can register for the required course through the respective CET. All the aspirants need to go through the eligibility criteria before the registration. The eligibility criteria details are available on the website as well as in University Admission Brochures. All aspirants should read it carefully before applying.

Courses Eligibility Details

1.	MBA	2 Years	A Candidate applying for the MBA Programme should have passed Graduation with 50% (45% in the case of SC/ST candidates) and above from any reputed College situated in India. Those candidates who have appeared in the final year Examination are also eligible to apply but such candidates will have to submit the marks statement at the time of admission. In such cases, admission of the student will remain provisional until the other necessary certificates in original are submitted to the Institute.
2.	BBA BBA(Hons)	3 Years 4 years	A candidate applying for the BBA Programme should have passed HSC (10+2) or equivalent from any Statutory Board situated in India. Those candidates who have appeared at the qualifying examination are also eligible to apply, but such candidates will have to submit the marks statement at the time of admission. In such cases, admission of the student will remain provisional until the other necessary certificates in original are submitted to the Institute.
3.	BCA BCA(Hons)	3 Years 4 years	
4.	LLB	3 Years	A candidate applying for the LLB 3 years Programme should have passed graduation with a minimum of 45% marks in case of general category (40% for SC/ST) from any reputed college situated in India. Those candidates who have appeared at the qualifying examination are also eligible to apply, but such candidates will have to submit the marks statement at the time of admission. In such cases, admission of the student will remain provisional until the other necessary certificates in original are submitted to the Institute.
5.	BBALLB	5 Years	A candidate applying for the BBA LL.B Programme should have passed HSC (10+2) or equivalent with a minimum of 45% in the general category (40% of total marks in case of SC/ST applicants) from any Statutory Board situated in India (As prescribed by Bar Council of India). Those candidates who have appeared at the qualifying examination are also eligible to apply but such candidates will have to submit the marks statement at the time of admission. In such cases, admission of the student will remain provisional until the other necessary certificates in original are submitted to the Institute.

- CET Entrance Test:** CET is Scheduled in April for MBA and in June for BBA/BBA(Hons), BCA/BCA(Hons), LLB & BBALLB. The schedule for the entrance test is given below:

The CET Entrance Test is a computer-based online Test. CET is conducted online in a test center where students need to report with admit card along with valid ID card. The syllabus for CET examinations are as follows:

BMAT Test (MBA)

The weightage of the BMAT test is 200 marks and 180 minutes duration. It consists of 200 multiple-choice questions of one mark each with four alternatives for each, with only one right/probable choice. There is no negative marking. The break-up of marks will be as follows:

BUMAT Test (BBA/BCA)

The weightage of the B-UMAT test is 200 marks and 150 minutes duration. It consists of 200 multiple-choice questions of one mark each with four alternatives for each, with only one right/probable choice. There is no negative marking. The break-up of marks will be as follows:

BV-LLB Test (LLB)/ BV-BBALAWUG (BBALLB)

The weightage of the BV-LLB/BBALAWUG test is 100 marks and 120 minutes duration. It consists of 100 multiple-choice questions of one mark each with four alternatives for each, with only one right/probable choice. There is no negative marking. The break-up of marks will be as follows:

3. **Counselling:** The schedule and venue of counselling will be notified on the BVDU website. Admission Counselling is conducted based on Merit/Rank secured in the final merit list of the respective course CET. The Seats are offered purely based on rank and availability of the seats for a particular course at a particular institute of the candidate's choice at the time of counselling in the concerned institute. Mere appearance in the entrance test and inclusion of name in the merit list does not confer any automatic rights to secure admission to the course offered by the institute. The Admission is subject to the fulfilment eligibility criteria. All aspirants need to present physically or their authorized representative in order to accept the offered seat during physical counselling.

In case of candidates securing equal aggregate marks, their relative rank will be determined on the basis of following order of preference:

- a) If equal, the candidate will be ranked according to their percentage of marks obtained at HSC or its equivalent examination.
 - b) If equal, the candidate will be ranked according to their percentage of marks obtained at SSC or its equivalent examination.
 - c) When all above scores are same, the candidate will be ranked on the basis of computerized random numbering.
4. **Admission:** In Physical counselling Provisional admission is offered after submission and scrutiny of the documents which are mentioned below:
- a) Statement of Marks (Last qualifying examination)
 - b) Passing/Degree certificate (Last qualifying examination)
 - c) Migration certificate from the University from which the candidate has passed the last examination. (other than Bharati Vidyapeeth (Deemed to be University).
 - d) Transference /Leaving Certificate from the College last attended.
 - e) Character Certificate from the Principal of the College last attended.
 - f) Affidavit regarding Gap in education on Rs 100/-stamp paper if applicable.
 - g) Caste Certificate (in case of SC/ST Candidates).
 - h) Caste Validity Certificate (for SC/ST Candidates).
 - i) Change in Name Certificate (if any for married female students).
 - j) DD of the requisite fees as per the fee structure.
 - k) 5 Passport-size recent photographs.

All the aspirants need to appear with the above-mentioned documents with originals and 2 sets of photocopies duly self-attested. After scrutiny of their Certificates at the institute level, the candidate's admission will be confirmed subject to payment of applicable fee and scrutiny of all certificates at the university level.
